The Greater CLE Youth Justice Collective, made up of the ACLU of Ohio, Children's Law Center, and the Schubert Center for Child Studies at Case Western Reserve University, engaged in a series of focus groups with Cleveland youth in order to understand how negative framing in the media and elsewhere can affect kids who are impacted by the criminal legal system.

Our Collective Goals are to:

1. Combat harmful rhetoric on safety and youth.
2. Humanize Cleveland's youth with the understanding that all kids are kids.
3. Foster greater understanding and empathy among policymakers, law enforcement, and the broader community.

Key Themes that Emerged from Youth Conversations

- Nearly half of the kids said guns became a survival instinct.
- The young people consistently connected mental health challenges to unresolved generational trauma, underscoring how grief and loss perpetuate cycles of harm.
- Over 2/3 of the girls and young women spoke specifically about intergenerational trauma.
- The teens mentioned sports, music, writing, art, drawing, journaling, and photography as helpful coping mechanisms that keep youth grounded and focused.
- Over 60% of youth lost at least one person to guns.

Safety is Complex

"Safety means having people you can trust to protect you, but we don't have that here."
