### **Overview**

Welcome to the ACLU of Ohio's latest edition of our Statehouse-to-Prison Pipeline Report. This report is our fifth full legislative session overview, spanning the past 10 years (5 legislative sessions). With this report, we seek to demonstrate the sheer volume of bills introduced and

passed by the Ohio General Assembly (OGA) designed to pack even more people into our overcrowded and expensive prisons and jails.

It is important to note all bills are not equal when it comes to their impact on mass incarceration. Some will have minimal effect because they target such a narrow type of behavior or action. While others will have a major impact, perhaps even necessitating the expansion of or building new prisons or jails.

As with past reports, we are compelled to include not just legislation that passed into law but also bills that were introduced

Ohio's prison system was designed to incarcerate about 37,000 people, yet our prisons housed 45,490 as of December 2024. **That's over 120% capacity.** Strikingly, this is actually an improvement from the days where our prisons were bursting at the seams with nearly 50,000 people.



but did not cross the finish line. Bills that do not become law still fuel a variety of mass incarceration problems. For example, inside and outside the Statehouse, these bills amplify the idea that the solution to various, sometimes complex, problems is to lock people away, or for longer periods of time. When that line of thinking permeates the Statehouse, we see more and more bills of this type.

It's important to consider a huge number of bills are introduced which do not pass in the first attempt. It may take one, two, three, or more legislative sessions before ultimate passage and enactment. Again, this perpetuates an atmosphere of mass incarceration by a thousand cuts.


More specifically, Statehouse-to-Prison Pipeline bills earn that designation by any combination of:

- 1. Creating a new criminal offense;
- 2. Enhancing punishments and penalties for current criminal offenses;
- 3. Expanding and tweaking the reach of current laws to include new actors and similar scenarios; and / or
- 4. Removing or altering time limits for prosecution of certain offenses.

# The 135th Ohio General Assembly (2023-2024)

From January 2023 to December 2024, 1,058 bills were introduced in the Ohio General Assembly (OGA). Of those, 79 bills (7.5%) are what we consider Pipeline bills. More specifically, **58 of the 716 (8.1%) House bills and 22 of the 342 (6.4%) Senate bills contained mass incarceration provisions.** 

### The 135th OGA introduced bill breakdown



In the 135th General Assembly, 14 Pipeline bills passed.

## Comparing the Last Five Legislative Sessions

Of the past five sessions (ten years) the ACLU of Ohio has been publishing the Statehouse-to-Prison Pipeline Report, the 135th GA shows improvement over the others in a few ways. 79 total Pipeline bills introduced is the lowest in five sessions. Additionally, the 135th OGA also introduced the least bills overall since the 131st OGA. Notably, the percentage of Pipeline bills to total bills is 7.5% – the best over this five-session period. However, looking at ten years of data shows the legislature has a "two steps forward, one step backward" approach when it comes to Pipeline bills. The trend is that there is no real trend and whether and how many Pipeline bills are introduced and ultimately passed largely comes down to the whims of current leadership.

## A Closer Look at the Pipeline

By far, the most consequential bill introduced last session was **House Bill 230**. This bill sought to significantly increase penalties for selling fentanyl/related compounds, heroin, cocaine, and methamphetamine.

Drug trafficking is already the #2 reason a person lands in an Ohio prison and has been the case for many years. We believe passage of HB 230 would have necessitated spending hundreds of millions of dollars over the coming years to build and operate at least one new prison while doing very little, if anything, to impact those harmed by the availability of these substances.

Indeed, the focus of the OGA, as well as other legislatures around the country, on fentanyl and related compounds is nothing more than an ongoing extension of the failed War on Drugs. This "war" remains a bipartisan one, as evidenced by the movement of this bill through the Ohio House.

HB 230 passed out of its original committee with an 11-1 vote. Because it contained an appropriation of funds, its next stop was the Finance Committee where it passed 12-0. The full House then approved it 80-13. Notably, legislators on both sides of the aisle who have publicly proclaimed the War on Drugs is a failure had no problem voting for HB 230. As is often the case in politics, rhetoric often does not match voting records. Ultimately, whether because of timing or the well-documented power struggles among the Republican caucus last session, HB 230 saw little action on the Senate side. But, another version of this bill has already reemerged this current session (the 136th OGA).

Per usual, we also saw a variety of bills to increase punishments for existing criminal offenses based on the category of victim. The goal of House Bill 139 was to raise penalties for Assault when the victim is a sports official, such as a referee. It passed the House 69-6. Senate Bill 88, a bipartisan bill, increased the offense of Aggravated Menacing when the victim is a utility worker. House Bill 525, another bipartisan bill, focused on assaults against school staff. Keep in mind, Ohio already has existing laws to penalize this behavior no matter the victim. These bills, like others before them, all sought to elevate some victims above others.

Responding to news headlines via legislation never ends. That is why we saw bipartisan bills like House Bill 328, which passed the House 93-2, and Senate Bill 165. Both bills increased theft penalties involving catalytic converters. House Bill 56 passed the House 83-6, the Senate 30-0, and is now law. It targets "hooning" i.e. street takeovers by people engaging in reckless, dangerous driving. Again, actions already covered by several laws existing before the passage of HB 56. House Bill 366 and Senate Bill 223 specifically targeted retail theft for further punishment, HB 366 passed the House 69-24, the Senate 30-0, and is now law.

Another example that may seem innocent and playful at first but would have severe negative real-world consequences if passed, was House Bill 700. Following a loss to Michigan by the Ohio State University football team in their home stadium, some Michigan players attempted to plant a flag with their team's colors on the Ohio State logo in the center of the field. This resulted in a scuffle between players and law enforcement intervened. HB 700 created not just a criminal offense, but a felony offense, for planting a flag specifically on, and only on, Ohio State's football field before, during, or after a game. In other words, HB 700 would have allowed for prison time for rival college football players for such an act, regardless of whether it led to any altercations or law enforcement involvement.

### The Criminalization of Democracy

An alarming new frontier in the Statehouse-to-Prison Pipeline emerged during the 135th General Assembly – the criminalization of democracy. Stemming from repeatedly debunked claims by President Trump that the 2020 election was "stolen," Ohio legislators began pushing for more election-related conduct to be illegal and subject to criminal penalties. Specifically, HB 1 of the 135th General Assembly's Special Session was passed to create new misdemeanor and felony level offenses for new classes of individuals, including green card holders, natural born citizens, and organizations who raise and spend money in support or opposition to ballot issue campaigns.

Additionally, through the general penalty provisions of the Ohio Rev. Code § 3599, it is now a first-degree misdemeanor offense to assist voters with filling out any election related form, except where the voter receiving assistance affirms they suffer from "blindness, disability, or illiteracy." What was once common practice during voter registration drives, petition circulation, or even spouses filling out each other's absentee ballot requests at the dinner table, is now illegal. There are no indications the OGA will halt this dangerous and corrosive practice in the 136th General Assembly. Many bills were left on the cutting room floor which, should they be re-introduced and signed into law, would further criminalize lawful election-related conduct.



## Positive Bills Introduced During the 135<sup>th</sup> OGA

For many years, the Ohio General Assembly's approach to mass incarceration has been a single giant bill, once every several years, that addresses and improves the workings of the

system(s) but does not provide needed, true comprehensive reform. These bills typically provide some relief regarding record sealing and/ or expungement, collateral sanctions, alternatives to prison, judicial release, and various other aspects of the criminal legal system. The ACLU of Ohio routinely supports these efforts. The most recent examples

**Collateral sanctions** are additional civil penalties that attach to a criminal conviction

of such omnibus bills that became law are **House Bill 86** (129th GA, effective Sep. 30, 2011), **Senate Bill 66** (132nd GA, effective Oct. 29, 2018), and **Senate Bill 288** (and its House companion, **House Bill 699,** 134th OGA, effective April 4, 2023).

Last session saw no major criminal legal system reform specific omnibus legislation. Instead, several piecemeal bills were introduced, and a few even passed. Most notable are **HB 29** and **SB 198** (amended into a lame duck "Christmas tree bill" – **HB 315**).

A Christmas tree bill is a political term referring to a bill that includes several, often unrelated, amendments.

### House Bill 29: Driver's License Suspensions

**Primary Sponsors:** Brewer (D); Humphrey (D)

CoSponsors: 7 D

Status: Signed by Governor

**Info:** Largely eliminated debt-related driver's licenses suspensions. Removes the possibility of a driver's license suspension for drug abuse offenses, except when a vehicle was used to further the commission of the offense.

Note: Senate Bill 37 (Blessing; Ingram) advanced these policy goals for much of the 135th OGA.

### Senate Bill 198: Vital Documents for Individuals Leaving Incarceration

Primary Sponsors: Lang (R); Manning (R)

**CoSponsors:** none at introduction

**Status:** Signed by Governor (as part of HB 315)

**Info:** Requires the Department of Rehabilitation and Correction (DRC) and the Department of Youth Services (DYS) to make available and submit completed applications for state identification cards or temporary identification cards on behalf of those in their custody and to initiate this process before the person's reentry. Also requires DRC to assist incarcerated people with obtaining vital government documents to assist them in obtaining post-release employment.

## The Pipeline


Of the 1,058 bills introduced during the 135th OGA, the following are what the ACLU of Ohio refers to as Pipeline bills. In short, these are bills that would put more people in Ohio's prisons and jails.

Like past reports, this list does not include bills where the punishment starts as a minor misdemeanor and/or a fine but ultimately scales up to possible prison or jail sentences with repeated violations. Bills like those do not lead to the overwhelming mass incarceration problems we wish to highlight in this report.

#### Key:

Primary Sponsor(s) = The legislator(s) responsible for the bill's creation and introduction. Cosponsors: Legislators who have formally signed on in support of the bill. Status: How far the bill progressed during the legislative session. Info: Brief detail regarding how the bill fuels the Statehouse-to-Prison Pipeline.

NOTE: There was also a "special session" in 2024 called by Gov. DeWine for the sole purpose of passing two election laws bills. To avoid confusion, House Bill 1 from that special session is included here as if were part of the regular, existing 135th General Assembly (session).

House Bill 20: Computer Crimes Primary Sponsor: Swearingen(R)

**Status:** 4 hearings in House Criminal Justice **Info:** Creates five new felony offenses and modifies two others, all relative to unauthorized tampering, theft, interference, etc. with computers, computer networks, and computer systems.
